
Strategas Macro Thematic Opportunities ETF (SAMT)

STRATEGY OVERVIEW



Our investment philosophy is constructed by identifying investable themes across multiple time horizons. We group these time horizons into three baskets 1.) Tactical – occurring in the next 3-4 months 2.) Episodic & Event Driven – occurring in the next business cycle 3.) Super-Cyclical – occurring beyond the next business cycle. We believe the greatest investment opportunities for the Macro Thematic Opportunities ETF exist in themes that are present in the Episodic & Event Driven and Super Cyclical time periods.

Time Horizons



A HIGH-CONVICTION, MACRO THEMATIC STRATEGY

The Fund's investment strategy seeks to identify companies benefiting from emerging macro themes. The strategy will typically be invested in 3 to 5 themes for which our research gives us the highest conviction. The Fund's thematic positioning is adjusted based on the shifts in macro trends to ensure the integrity of each theme's investment thesis and the relevancy of its constituents.

DISCIPLINED INVESTMENT PROCESS

We employ a multi-step investment process to uncover growth opportunities. We leverage Strategas' macro research to target themes that we believe have an identifiable macro catalyst and will maintain or experience an increase in "thematic momentum" relative to other themes over a short-to-intermediate time horizon. Once a theme is established, we deploy a multi-factor, fundamental research approach to construct a portfolio composed of U.S.-listed stocks across the market-cap spectrum that meet our liquidity parameters. The fund will be adjusted over time by rotating in-and-out of themes and adjusting portfolio positioning based on macroeconomic factors.
